- F 11031 Elizabeth³ Chamberlin, b. About 1835, probably Dover Twp., Monmouth Co., NJ. Married Ezekiel Moore and had issue. Died about 1875-1895. +
- F 11032 Mary³ Chamberlin, b. About 1836, probably Dover Twp., Monmouth Co., NJ. Died young, about 1838, "aged 17 months."
- M 11033 Freedom³ Chamberlin, b. About 1838, probably Dover Twp., Monmouth Co., NJ. Married Rebecca Tilton and had issue. +
- M 11034 Jackson³ Chamberlin, b. About 1840, probably Dover Twp., Monmouth Co., NJ. Married Rachel Moore and had issue. +
- M 11035 John³ Chamberlin, b. About 1842, probably Dover Twp., Monmouth Co., NJ. Married Mary Moore and had issue. +
- F 11036 Margaret³ Chamberlin, b. About 1844 (?), probably Dover Twp., Monmouth Co., NJ. Married John Buckalow. They lived at New Egypt, NJ. In 1895, she was dead but he was living. Not found in the census (which one?) for some reason. Four children: Vesta Ann, Josephine, Laura, Henry, and Howard Buckalow. In 1895, they were all living except Josephine, who was dead.
- F 11037 Lucy Ann³ Chamberlin, b. About 1846 (?), probably Dover Twp., Monmouth Co., NJ. Died young, aged about 3 months.

- M 11038 William Augustus³ Chamberlin, b. About 1848, probably Dover Twp., Monmouth Co., NJ. Married Sarah Horner and had issue. +
- F 11039 Louisa³ Chamberlin, b. 23 Aug 1851, probably Dover Twp., Monmouth Co., NJ. Married Nathan Moore. In 1895, they were living at Toms River, NJ. Four children, Frances, Abigail, Arthur, and George Moore.

William was alive in 1870 at the time of the census, but was dead in 1895. In 1895, his widows Abbie, gave information about the family to B.F. Cummings.
